

## ONLINE GIFTING MADE EASY

The **GoTuition**® gifting portal is a free, online tool that you can use to create a gifting profile for your Beneficiaries, allowing friends and family to easily contribute to your Accounts.



### How to Get Started

Follow these steps to sign up, customize and share your GoTuition® profile.



**Log in to your Maryland 529 Account.**

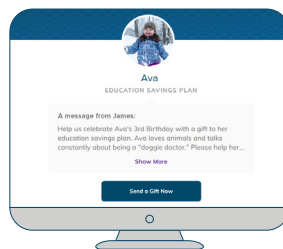


**Click the GoTuition® gifting portal link** and follow the instructions to sign up. Choose the Account you would like to have gifts applied to.



**Create a personalized gifting profile for each of your Beneficiaries.** Each Beneficiary will have their own personalized gifting link. No matter how often you update their profile page, the URL will remain constant and never expire.

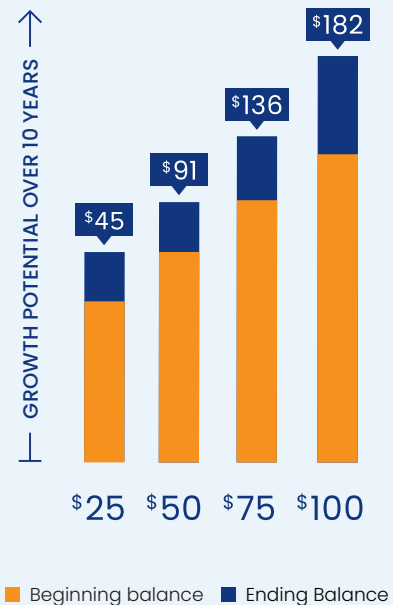
You can customize your profile picture and welcome message based on what you would like to say about your child. Some ideas include mentioning your child's age, grade, or dreams about what they want to be when they grow up. If you have a special event or holiday coming up, highlight it and share with friends and family so that they know just what to give your child. You can change your profile as often as you like, such as updating the message as your child grows or for specific times of the year in which your child might receive gifts.



**Share the link with your family and friends.** You can share the URL for your Beneficiary's gifting profile however you wish. There are links that can help you share through Facebook, Twitter, or email. You can also copy and paste the URL into anything you'd like such as party invitations and birth announcements.

**Gift contributions will be posted immediately to your Gift History page**, which shows both completed and pending gifts. To view this page, **log in** to your Maryland 529 Account and select "View Dashboard" from the **GoTuition®** tile. From your dashboard, you will be able to select "View Gift History" under the gift total to see a list of all gifts received, including the name of the giver, amount of gift, and date given.

Gift contributions are indicated with a "**GoTuition®**" transaction type in the transaction history on your Account dashboard. You will receive a confirmation for each gift via the delivery (i.e., paperless or regular mail) that you indicated on your Account. Confirmations are mailed the following business day after the gift is contributed to your Account.

## Quick Facts

There are no fees for using the gifting portal or for any gift contributions your friends and family members make through the portal.

We take privacy very seriously. Only those who have access to your URL may visit or contribute to your gifting profile.

You can maintain and update your child's profile based on birthdays, milestones, or to show off new school photos.

The minimum gift is \$25, while the maximum one-time gift is \$100,000.

Gifters cannot set up recurring gifts, but they can make additional contributions simply by saving the link and using it again as needed.

To suspend gifting for any reason, just log in, go to your **GoTuition®** dashboard, and toggle the on/off switch.
